The Fredericktown Village council met in regular session on August 16, 2021 at 7:00 p.m. at the Fredericktown Municipal Building.

PRESENT: Council Members Brewer, De Rojas, Lanuzza, Shoemaker, McKnight and Van Nostrand; Fiscal Officer Graves; Village Administrator Snell.

Mayor Day called the meeting to order at 7:00 p.m.

MINUTES: Lanuzza made a motion to approve the July 19, 2021 minutes with correction of verbiage under new business regarding speed signs by De Rojas. Seconded by Brewer. All yea,

INTRODUCTION OF GUESTS:

LEGISLATION:

ORDINANCE NO. 2021-19 - AN ORDINANCE AUTHORIZING THE FISCAL OFFICER TO REQUEST AN AMENDED CERTIFICATE OF ESTIMATED RESOURCES FOR THE VILLAGE OF FREDERICKTOWN

Lanuzza made a motion to pass Ordinance 2021-19. Seconded by Shoemaker. All Yea.

- 7 High Street – new owners have been contacted and will have lawn mowed soon. They hope to start renovation within in the next 90 days. 181 South Main Street – contractor is working on the property.

- Street paving project is tentatively set to begin the third week in September. Mill Street bridge will be closed for approximately two weeks during the paving project.
