

**PEDDLERS/SOLICITORS LICENSE OR REGISTRATION  
FREDERICKTOWN ORDINANCE # 2017-12**

No person shall engage in the business or activity of peddler or solicitor as defined in Section 1, and Section 2(a) without first obtaining a license or certificate provided in Sections 3 and 4 and complying with other applicable Sections of the Ordinance.

**It is unlawful to peddle/solicit/canvass from 8PM to 9AM or on any Sunday or Federal Holiday, or to peddle/solicit/canvass any premise posted with a "NO SOLICITATION SIGN," or to peddle/solicit/canvass any person, residence, or business address which was placed on the "Do Not Solicit list" maintained at the Village of Fredericktown ("Village") office. Persons soliciting/peddling/canvassing in the Village must carry their license at all times.**

**CHARITABLE/RELIGIOUS REGISTRATIONS:** Individuals and organizations exempt from liensing by Section 2(b)(Charitable/Religious Organizations) are required to register with the Village pursuant to Section 3, and receive a certificate-

**Group Applications:** Per Section 3 (b), an organization may place several peddlers/solicitors in the Fredericktown Village simultaneously with one application. Separate registration certificates shall be issued to each applicant or in lieu thereof, the Village may accept separate information cards issued to each peddler/solicitor by the organization containing the minimum information required in Section 3 b (1) through (6). Copies of all information cards must be provided to the Village prior to any peddler/solicitor activity.

**PEDDLER/SOLICITOR LICENSE:** Section 4 requires applications for licenses for peddlers or solicitors shall be filed, at least 48 hours ahead of the intended peddling or soliciting activity, with the Village Office on a form to be furnished by the Village office, which shall require, but shall not be limited to, the following information: Any license issued under this Ordinance shall be carried by any peddler or solicitor at all times when peddling or soliciting inside of the corporate boundaries of the Municipality, and shall be exhibited upon request to any person being solicited, any police officer, or other Village official. Licenses issued are non-transferable and shall not be used by any person other than the person identified on the license.
