## **VISITOR COMMENTS:**

• David Gerhart, On-the-Rise BBQ discussed the recent changes regarding zoning of mobile food vendors. He noted that the zoning code states that there are three types, but only two are list. Mayor Day said there are only two (three is a misprint). He also wanted clarification on Village sponsored events where the fee is waived.
