These will require minimal funds from the Village, at the most 5%.
- Hobson asked if we had heard anymore from the company that has installed underground fiber optic cable in town, and how they were going to implement their services.

• de Rojas - Public works met and discussed stop signs that are replacing the traffic lights on Main Street. de Rojas made a motion to initiate discussion with ODOT about adding LED stop signs at the three intersections. Seconded by Shoemaker. All yea.
