- 4. THE FISCAL OFFICER IS HEREBY DIRECTED TO CERTIFY THE LEVY TO THE AUDITOR <u>AND</u> THE BOARD OF ELECTIONS, KNOX COUNTY, OHIO ("BOE"). CERTIFICATIONS SHALL INCLUDE COPIES OF <u>ALL</u> OF THE FOLLOWING DOCUMENTS:
 - a. RESOLUTION OF NECESSITY (RESOLUTION NO. 2024-06) ADOPTED ON APRIL 1, 2024 AND,
 - b. CERTIFICATION OF THE AUDITOR; AND,
 - c. RESOLUTION TO PROCEED (THIS RESOLUTION).

CERTIFICATION SHALL OCCUR BY NO LATER THAN 4:00 PM ON AUGUST 7, 2024 (90 DAYS PRIOR TO THE ELECTION).

THE FISCAL OFFICER SHALL ALSO NOTIFY THE BOE TO CAUSE NOTICE OF THE ELECTION ON THE QUESTION OF LEVYING THE TAX TO BE GIVEN AS REQUIRED BY LAW.

5. THE BOE IS HEREBY DIRECTED TO SUBMIT SUBSTANTIALLY THE FOLLOWING QUESTION TO THE ELECTORS AT THE ELECTION:

OFFICIAL QUESTIONS AND ISSUES BALLOT GENERAL ELECTION NOVEMBER 5, 2024 PROPOSED TAX LEVY (RENEWAL) VILLAGE OF FREDERICKTOWN KNOX COUNTY, OHIO

A MAJORITY AFFIRMATIVE VOTE IS NECESSARY FOR PASSAGE

A RENEWAL TAX FOR THE BENEFIT OF THE VILLAGE OF FREDERICKTOWN, KNOX COUNTY, OHIO FOR THE PURPOSE OF CONTINUING CURRENT OPERATIONS THAT THE COUNTY AUDITOR ESTIMATES WILL COLLECT \$60,300.00

ANNUALLY, AT A RATE NOT EXCEEDING 1.5 MILLS FOR EACH ONE DOLLAR
