*RESOLVED, By the Council of the Village of **Fredericktown, Knox** County, Ohio that the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted; and be it further*

*RESOLVED, that there be and it's hereby levied on the tax duplicate of said Village the rate of each tax necessary to be levied within and without the ten-mill limitation as follows:*
