- h. THE TAX WILL BE FIRST LEVIED AND COLLECTED AS FOLLOWS:
  THE TAX YEAR IN WHICH THE TAX WILL FIRST BE LEVIED IS 2026.
  THE CALENDAR YEAR IN WHICH THE TAX WILL FIRST BE COLLECTED IS 2027.
- i. THE VILLAGE HAS TERRITORY IN KNOX COUNTY AND EACH OF THE FOLLOWING LISTED COUNTIES: NONE.

4. THE FISCAL OFFICER IS HEREBY DIRECTED TO CERTIFY THE LEVY TO THE AUDITOR <u>AND</u> THE BOARD OF ELECTIONS, KNOX COUNTY, OHIO ("BOE"). CERTIFICATIONS SHALL INCLUDE COPIES OF <u>ALL</u> OF THE FOLLOWING DOCUMENTS:

- a. RESOLUTION OF NECESSITY (RESOLUTION NO. 2025-08) ADOPTED ON APRIL 7, 2025 AND,
- b. CERTIFICATION OF THE AUDITOR; AND,
- c. RESOLUTION TO PROCEED (THIS RESOLUTION).

CERTIFICATION SHALL OCCUR BY NO LATER THAN 4:00 PM ON AUGUST 6, 2025 (90 DAYS PRIOR TO THE ELECTION).

THE FISCAL OFFICER SHALL ALSO NOTIFY THE BOE TO CAUSE NOTICE OF THE ELECTION ON THE QUESTION OF LEVYING THE TAX TO BE GIVEN AS REQUIRED BY LAW.

#### OFFICIAL QUESTIONS AND ISSUES BALLOT GENERAL ELECTION NOVEMBER 4, 2025 PROPOSED TAX LEVY (RENEWAL) VILLAGE OF FREDERICKTOWN KNOX COUNTY, OHIO A MAJORITY AFFIRMATIVE VOTE IS NECESSARY FOR PASSAGE

A RENEWAL TAX FOR THE BENEFIT OF THE VILLAGE OF FREDERICKTOWN, KNOX COUNTY, OHIO FOR THE PURPOSE OF PROVIDING AND MAINTAINING POLICE PROTECTION THAT THE COUNTY AUDITOR ESTIMATES WILL COLLECT \$119,300.00 ANNUALLY, AT A RATE NOT EXCEEDING 3 MILLS FOR EACH ONE DOLLAR OF TAXABLE VALUE WHICH AMOUNTS TO \$105.00 FOR EACH ONE HUNDRED THOUSAND DOLLARS OF THE COUNTY AUDITOR'S APPRAISED VALUE FOR FIVE YEARS COMMENCING IN 2026, FIRST DUE IN CALENDAR YEAR 2027.
