**A RESOLUTION TO PROCEED WITH SUBMISSION OF THE QUESTION OF LEVYING A RENEWAL TAX IN EXCESS OF THE TEN-MILL LIMITATION FOR THE PURPOSE OF PROVIDING AND MAINTAINING MOTOR VEHICLES, COMMUNICATIONS, OTHER EQUIPMENT, BUILDINGS, AND SITES FOR SUCH BUILDINGS USED DIRECTLY IN THE OPERATION OF A POLICE DEPARTMENT, FOR THE PAYMENT OF SALARIES OF PERMANENT OR PART-TIME POLICE, COMMUNICATIONS, OR ADMINISTRATIVE PERSONNEL TO OPERATE THE SAME, INCLUDING THE PAYMENT OF ANY EMPLOYER CONTRIBUTIONS REQUIRED FOR SUCH PERSONNEL UNDER SECTION 145.48 OR 742.33 OF THE REVISED CODE.**

**WHEREAS, THE VILLAGE OF FREDERICKTOWN PREVIOUSLY PASSED RESOLUTION 2025-11 AND IT IS NOW NECESSARY TO REPEAL AND REPLACE SUCH RESOLUTION TO HAVE CORRECT OHIO REVISED CODE AND BALLOT LANGUAGE INCLUDED**

**WHEREAS, THE KNOX COUNTY (“AUDITOR”) HAS CERTIFIED THE FOLLOWING INFORMATION TO THE BOARD:**

**RESOLUTION**

**NOW THEREFORE, BE IT RESOLVED, BY COUNCIL,**

AT LEAST TWO-THIRDS (2/3) OF ALL MEMBERS

OF COUNCIL CONCURRING, AS FOLLOWS:

1. COUNCIL SHALL PROCEED WITH THE SUBMISSION OF THE QUESTION OF THE TAX ELECTORS.
2. THE RATE AMOUNTS TO THE FOLLOWING FOR EACH ONE HUNDRED OF TAX VALUATION AS ESTIMATED BY THE AUDITOR, IS AS FOLLOWS:
  - a. 3 MILL(S);
  - b. THIS RATE AMOUNTS TO THE FOLLOWING FOR EACH ONE HUNDRED THOUSAND DOLLARS OF TAX VALUATION: \$105.00
  - c. IF THE LEVY IS A RENEWAL LEVY OR REPLACEMENT LEVY, THIS RATE:  
  X   IS THE SAME RATE AS THE EXISTING TAX LEVY.  
       IS NOT THE SAME RATE AS THE EXISTING TAX LEVY AND IS EITHER:  
       A REDUCTION, THE EXTENT OF THE REDUCTION BEING:        MILL(S)

  - a. THE PURPOSE OF THE TAX IS AS FOLLOWS: PROVIDING AND MAINTAINING POLICE PROTECTION.
  - b. THE TYPE OF LEVY IS AS FOLLOWS:

- d. THE TERM OF THE TAX IS AS FOLLOWS (IN YEARS OR CONTINUING): FIVE YEARS.
  - e. THE TERRITORY WHERE THE TAX IS TO BE LEVIED IS AS FOLLOWS:  
  X   UPON THE ENTIRE TERRITORY OF THE VILLAGE  
       IF AUTHORIZED BY THE REVISED CODE, THE FOLLOWING DESCRIBED PORTION OF  
THE TERRITORY OF THE VILLAGE:
  - f. THE DATE OF THE ELECTION AT WHICH THE QUESTION OF THE TAX SHALL APPEAR ON THE  
BALLOT IS AS FOLLOWS (“ELECTION”); TUESDAY, NOVEMBER 4, 2025.
  - g. THE TERRITORY WHERE THE BALLOT MEASURE IS TO BE SUBMITTED IS AS FOLLOWS:  
  X   UPON THE ENTIRE TERRITORY OF THE VILLAGE  
       IF AUTHORIZED BY THE REVISED CODE, THE FOLLOWING DESCRIBED PORTION OF  
THE TERRITORY OF THE VILLAGE.
  - h. THE TAX WILL BE FIRST LEVIED AND COLLECTED AS FOLLOWS:  
THE TAX YEAR IN WHICH THE TAX WILL FIRST BE LEVIED IS 2026.  
THE CALENDAR YEAR IN WHICH THE TAX WILL FIRST BE COLLECTED IS 2027.
  - i. THE VILLAGE HAS TERRITORY IN KNOX COUNTY AND EACH OF THE FOLLOWING LISTED  
COUNTIES: NONE.
4. THE FISCAL OFFICER IS HEREBY DIRECTED TO CERTIFY THE LEVY TO THE AUDITOR AND THE  
BOARD OF ELECTIONS, KNOX COUNTY, OHIO (“BOE”). CERTIFICATIONS SHALL INCLUDE COPIES OF  
ALL OF THE FOLLOWING DOCUMENTS:
- a. RESOLUTION OF NECESSITY (RESOLUTION NO. 2025-08) ADOPTED ON APRIL 7, 2025  
AND,
  - b. CERTIFICATION OF THE AUDITOR; AND,
  - c. RESOLUTION TO PROCEED (THIS RESOLUTION).

CERTIFICATION SHALL OCCUR BY NO LATER THAN 4:00 PM ON AUGUST 6, 2025 (90 DAYS PRIOR TO  
THE ELECTION).

THE FISCAL OFFICER SHALL ALSO NOTIFY THE BOE TO CAUSE NOTICE OF THE ELECTION ON THE  
QUESTION OF LEVYING THE TAX TO BE GIVEN AS REQUIRED BY LAW.

5. THE BOE IS HEREBY DIRECTED TO SUBMIT SUBSTANTIALLY THE FOLLOWING QUESTION TO THE ELECTORS AT THE ELECTION:

A RENEWAL TAX FOR THE BENEFIT OF THE VILLAGE OF FREDERICKTOWN, KNOX COUNTY, OHIO FOR THE PURPOSE OF PROVIDING AND MAINTAINING MOTOR VEHICLES, COMMUNICATIONS, OTHER EQUIPMENT, BUILDINGS, AND SITES FOR SUCH BUILDINGS USED DIRECTLY IN THE OPERATION OF A POLICE DEPARTMENT, FOR THE PAYMENT OF SALARIES OF PERMANENT OR PART-TIME POLICE, COMMUNICATIONS, OR ADMINISTRATIVE PERSONNEL TO OPERATE THE SAME, INCLUDING THE PAYMENT OF ANY EMPLOYER CONTRIBUTIONS REQUIRED FOR SUCH PERSONNEL UNDER SECTION 145.48 OR 742.33 OF THE REVISED CODE. (R.C. 575.19(J)) THAT THE COUNTY AUDITOR ESTIMATES WILL COLLECT \$119,300.00 ANNUALLY, AT A RATE NOT EXCEEDING 3 MILLS FOR EACH ONE DOLLAR OF TAXABLE VALUE WHICH AMOUNTS TO \$105.00 FOR EACH ONE HUNDRED THOUSAND DOLLARS OF THE COUNTY AUDITOR'S APPRAISED VALUE FOR FIVE YEARS COMMENCING IN 2026, FIRST DUE IN CALENDAR YEAR 2027.
