

ORDINANCE NO. 2018-25

AN ORDINANCE ESTABLISHING SANITARY SEWER RATES FOR CUSTOMERS OF THE VILLAGE OF FREDERICKTOWN, OHIO

WHEREAS, the Council of the Village of Fredericktown is responsible for the collection and treatment of wastewater through the Fredericktown wastewater system, and the collection of sufficient revenues for the proper maintenance of the wastewater systems; and,

WHEREAS, because of mandates from the Ohio Environmental Protection Agency to upgrade the Fredericktown Wastewater Treatment Plant to meet current and future water quality standards and additional expenditures for the operation and maintenance of the present system and projected revenues are insufficient to meet current and anticipated future operational and debt expenses, it is necessary that the sewer service charges be adjusted accordingly.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the Village of Fredericktown, Knox County, Ohio, that the rates to be charged for sewer service are as follows:

Section 1. Beginning with the January 1 utility billing from 2019 through 2028, the sanitary sewer sanitary sewer rate to be paid by metered Village customers shall be as follows:



- Section 2. Usage outside of the Village corporation limits shall reflect a rate surcharge of 60%.
- Section 3. Structures located inside Village corporation limit, connected to the Village's sanitary sewer system, with no meter connected to their water system, shall pay a flat fee of \$116.39 per monthly billing beginning January 1, 2019. This flat fee shall increase by an additional 3% the first billing in 2020, 2021 and 2022, and this fee shall increase by an additional 1% the first billing each year from 2023 through 2028.
- Section 4. Structures located outside Village limits, connected to the Village's sanitary sewer system, with no meter connected to their water system, shall pay a flat fee of \$186.22 per monthly billing beginning January 1, 2019. This flat fee shall increase by an additional 3% the first billing in 2020, 2021 and 2022, and this fee shall increase by an additional 1% the first billing each year from 2023 through 2028.
- Section 5. Sanitary sewer revenues collected shall be apportioned whereas forty-two (42) percent of the said revenues shall be used for operations, maintenance and repair expenses of the wastewater system and the remaining fifty-eight (58) percent of the said revenues shall be used solely for debt service.
- Section 6. The Fiscal Officer of the Village of Fredericktown is hereby authorized and directed to render monthly billings, in accordance with and pursuant to the terms, provisions and conditions of this Ordinance.
- Section 7. Any and all resolutions, rules and regulations heretofore adopted by the Village of Fredericktown, or parts thereof in conflict with the terms, provisions and conditions of this Ordinance, be, and in the same are herewith repealed.
- Section 8. This Ordinance shall take effect and be in full force on the earliest date as allowed by law.
